Option 1 Upfront Fees

a) Internet Banking – Direct Deposit

A reference with your deposit is required, please use the below example using your surname with no space then your first name initial space fees e.g.

Option 2 FEE-HELP for ACT Enrolments

Obtain a FEE-HELP Info Booklet from the front office.

If you enrol in a unit of study as a fee-paying (non-Commonwealth supported) student:

- you must pay full tuition fees for your studies
- the Commonwealth does **not** contribute towards the cost of your education
- you may be eligible for a FEE-HELP loan to help pay your tuition fees.

This section has been designed to assist you in understanding the eligibility requirements for applying for FEE-HELP assistance.

What is FEE-HELP?

FEE-HELP is a loan given to eligible fee-paying students (Australian Citizens) to help pay part or all of their tuition fees.

FEE-HELP limit

You can borrow up to the amount of the tuition fee being charged by your provider for your unit of study. However, over your lifetime you can borrow only up to the FEE-HELP limit. In 2007, the FEE-HELP limit is \$80,000, and \$100,000 for students studying dentistry, medicine or veterinary science. This amount is indexed each year.

A loan fee of 20% applies to FEE-HELP loans for undergraduate courses of study. The FEE-HELP limit does not include the loan fee. No loan fee applies to FEE-HELP loans for postgraduate courses (Grad Dip Div, MDiv, MA).

The Australian Government pays the amount of the loan directly to ACT which then makes payment (less its administration fee) to the College.

Students repay their loan through the tax system once their income is above the minimum threshold for compulsory repayment.

FEE-HELP began on 1 January 2005 and is available to all eligible fee-paying students.
