VARIATION OF ENROLMENT

DEFINITIONS:

Administrative Date:

The date after which payment of a Variation of Enrolment Fee (VEF) is required.

Census Date:

The date against which the enrolled load in a unit is tallied. [While this is especially relevant for ACT units and FEE-HELP, it is also used for Vose awards.]

Withdrawal Date:

The date before which a student must withdraw from a unit so as not to incur academic penalty.

Notes:

A Variation of Enrolment form must be completed. Actions and fees outlined below will be effective at the time of form submission.

An appointment with the Academic Dean is recommended.

VEF is to be paid to Vose at the time of variation, irrespective of whether the student is using FEE-HELP.
